Safety Plan	Safety cover provided as described below
Emergency Plan	In the Event of an Emergency or suspected emergency the organisers should be notified and the emergency services called.
Welfare and Safeguarding Plan	The event adopts the Paddle UK policy for welfare and safeguarding, in the event of a suspected incident the organisers should be notified, and the emergency services will be contacted if required.
Evacuation Plan	If the wider areas need to be evacuated it is presumed this will be co-ordinated by the relevant authorities or emergency services.
Insurance Cover Checks	All competitors will be checked for insurance cover at race entry as either having: <ul style="list-style-type: none"> - British Canoeing membership. - Affiliated club British Canoeing membership.
Incident reporting	Following any Safety, Emergency, Safeguarding or evacuation incident a Paddle UK incident form shall be submitted as a record of the situation.
Emergency	Call 999 or 112 and request the correct service, explain the situation and contact the race organiser as soon as possible.

Lack of Paddler Competence	Paddlers	<p>All entrants or person in “loco Parentis” must complete a separate WWR entry form stating the paddler is competent and fit to race the WWR race on the conditions and distance etc. on the day.</p> <p>Paddlers are solely responsible for their own competence, medical fitness, endurance to complete the race and issues and welfare undertaking the race in the conditions present on the day.</p> <p>All Paddlers and parents must follow instructions and comply with any safety, plans and directions from the organisers. It is their responsibility to acquaint themselves with this.</p> <p>Event description clearly describes the severity of course, and the fact that paddlers need to be self-supporting on the river section.</p>	Any new competitors to the race are asked to come and speak to the organisers immediately after the briefing	Event Organiser and competitor	At the briefing

Missing Paddler(s) & or Children	Paddlers	<p>The race is on a small site and supervised along its length. Paddlers withdrawing from the race are advised to report to Control. Where possible, a bib system will be used and bibs checked in. A missing bib will instigate a search.</p> <p>Paddlers/parents briefed that under 16s are not allowed to be left on their own - a responsible adult needs to be on site with children.</p> <p>Missing children or other vulnerable persons should be reported to control where a search will be instigated or police informed.</p>	<p>Event team to be in contact throughout the event to ensure that all expected paddlers are accounted for.</p> <p>Paddlers briefed as to their responsibility to others throughout the event.</p>	Event Organiser Start and Finish Team	On the day and at the Briefing
Injury to Non-Paddlers and Members of the Public	Public Event Team Spectators	<p>The race takes place within the grounds of Bradford & Bingley Sports Club so there are likely to be participants of other sports present in the vicinity of the race. Paddlers should watch when they move boats around, paddles etc. Also it is suggested no paddler under 16 should be allowed to move around the centre for any reason e.g. taking canoes to river, going to the toilets etc., on their own (nor be left on their own).</p>	<p>Paddlers briefed:</p> <ul style="list-style-type: none"> - not to block footpaths - take care when they move boats and equipment around the site. - boats to be secured in windy weather. Moving Water	<p>Paddlers</p> <p>Event Safety Team</p> <p>Starter</p> <p>Spectators</p>	<p>All WWR paddlers or officials getting on the water MUST wear a buoyancy aid.</p> <p>Spray Deck are highly recommended.</p> <p>It is recommended officials doing start and finish and parents, spectators etc., if on the bank and potentially prepared to intervene in a rescue wear a buoyancy aid.</p> <p>Any competitor coming across another competitor in trouble must stop and give assistance.</p> <p>Each competitor must wait on the water at the finish for the next 2 competitors to finish before leaving the water.</p> <p>Chaperones are allowed to accompany less competent paddlers during the race.</p> <p>Paddlers to be careful getting in and out and request assistance if required.</p>	Paddler safety to be discuss at the briefing	Event Organiser	On the day at Briefing
Drowning	Paddlers	<p>All paddlers are required to wear and approved buoyancy aid, each paddler is responsible for ensuring the buoyancy aid is in good condition and suitable for the event.</p> <p>Any competitor coming across another competitor in trouble must stop and give assistance.</p>	Reminder given at the race briefing	Event Organiser	On the Day

Capsize	Paddlers	<p>IN ALL CASES THE PADDLER TAKES PRIORITY OVER SAVING BOAT AND/OR EQUIPMENT</p> <p>WWR code of conduct requires all paddlers to offer support to other paddlers when requested or if they see someone in potential difficulty with penalty of disqualification for life from competitive canoeing unless at risk/danger themselves.</p> <p>The paddler should get to the bank as quickly as possible with their canoe and paddle if they can. If they need help, they MUST stop the next paddlers by calling for help from them. The water current may be strong, and some paddlers may have difficulty swimming against this. The finished paddlers must be alert to the paddlers on the race course and go to help immediately. Experienced paddlers will be asked to stay on the water (if they agree) to assist with safety in addition to the two finish paddlers on standby.</p>	Reminder given at the race briefing	Event Organiser	On the Day

High water levels	Paddlers Event Team	The River Aire is a natural river lined with trees and other hazards. At low water this present little risk, however the river can rise rapidly in wet weather and as the river rises the risk of becoming entangled and entrapped in trees and other hazards increases, quickly. Any specific hazards will be highlighted during the briefing. We often recommend younger participants are escorted, we can sometimes help and provide escorts down the course.	Review water levels and weather conditions in the days running up to the event to prepare additional mitigations if required. Lightning Strike	Paddlers Event Team Spectators	If there are concerns about potential storms. Lightning will be tracked using a site such www.lightningmaps.org . If lightning is within 10km of the event, racing will immediately stop, paddlers will be removed from the water as quickly as possible, and all will be advised to seek shelter. Weil's Disease	Paddlers Event Team	Washing Facilities are available in the pub toilets. WEIL'S DISEASE Weil's Disease is a RARE but very serious illness which is caused by bacteria carried in the urine of rats (and some other animals). It can be contracted anywhere but especially around waterways. The descending scale of risk is: Stagnant water, canals and slow-moving rivers (particularly after flash floods), swifter streams.	Paddler and volunteer briefing on hazards and symptoms: Precautions: <ul style="list-style-type: none"> - Avoid capsize drill or rolling in stagnant or slow-moving water - Wash or shower after canoeing Cover minor scratches on exposed parts of the body with water-proof plaster - Use footwear to avoid cutting feet Should you become ill after canoeing (2-19 days) with a flu-like illness (temperature, aching limbs & joints) call your doctor and tell him/her you are a canoeist and may have come into contact with the Leptospirosis bacteria Paddlers briefed to report any infection to Paddle UK incident reporting	Event Organiser Paddlers Event Volunteers	On the Day
