Description of assessment	Wild Water Event Specific Risk Assessment: Llangollen, Serpents Tail & Classic Course – ECA Cup Classic & Sprint Events – 21 & 22 Nov 2026
Organisers and Experience	<p>The event is organised by the WWR Committee. Event Safety Officer(s)	Jamie Christie, last event Safety course completed January 2025, Dan Marsland. Rtd Lincolnshire Fire & Rescue incident commander.
Safeguarding	Helen Christie, is a retired primary school teacher and has completed the PUK Safeguarding training courses as identified and a Scouting Safeguarding course that is accepted by Paddle UK.

Location Details	<p>Llangollen Serpents Tail White Water Course, Adjacent to the Chain Bridge Hotel, Llangollen.</p> <p>The Sprint Race involves paddling first through flat but moving, sometimes turbulent (grade 2/3) water from the start under the Chainbridge and through the Serpents Tail Section to the finish on exiting the Serpents Tail section. The serpents tail section is a small low level gorge where water is channelled through an open passage in the rocks to create the moving water course.</p> <p>The Classic course starts below the Horseshoe falls above the Chain Bridge, passes through the Serpents tail and continues downstream to the finish, the steps on river right immediately before the weir above Town Falls. Access to the bank after the serpents tail is difficult due to land ownership and access.</p> <p>The river will be open to other paddlers who are not participating in this event.</p>

	<p>There is parking in the National Park car park and restricted public access to the course. Access to the serpent's tail section is via fixed ladders and onto rocks and traverse across these to the water section.</p> <p>The location is part of an area of natural beauty, and it is foreseeable that members of the public will be in a vicinity during the race.</p>
Safety Plan	<p>Safety cover will be provided. It is planned to have on the bank safety cover with people that have completed the Stadium Safety course at the Serpents Tail. It is also a requirement in the WWR racing rules that at least 2 racers remain at the finish until the next paddler completes the course.</p> <p>A minimum of 2 water safety personnel that have completed the Stadium Safety course will be on bankside; they will be named in the Event Plan. BA/Life jackets will be worn. Each person will have a throwline and a knife. In addition to the dedicated bank-side team, there will be a coaches and supporters within view of the course who have competence and experience in water safety and rescue. In the event of a serious incident they would be available to support as required.</p> <p>The bank side safety will be located downstream of the highest risk areas for WWR racers. 1) Below the initial drop into Serpents tail and on the exist to Serpents Tail.</p> <p>The nominated first aider is Jamie Christie</p>

Review Notes:

No incidents to record during the 2025 event and water levels remained within safe range for the event. At 0.8m to 0.9m at Corwen gauge it made a tricky entry to the Serpents tail section resulting in a number of capsizes, but bankside safety cover managed these satisfactorily. Control measures for Hypothermia updated with the dedicated shuttle bus drivers to transport paddlers from the classic finish to the start and during practice runs. Event plan updated to reflect this change.
